SECOND PROSPECTUS SUPPLEMENT INCORPORATING BY REFERENCE THE ANNUAL REPORT ON FORM 20-F FOR THE YEAR ENDED DECEMBER 31, 2020, AS FILED WITH THE U.S. SECURITIES AND EXCHANGE COMMISSION (THE "SEC") ON FEBRUARY 26, 2021 (THE "ANNUAL REPORT") OF BANCO SANTANDER CHILE AND UPDATING THE BASE PROSPECTUS

Banco Santander Chile (the "Issuer" or with its consolidated subsidiaries "Santander Chile Group") has prepared this second prospectus supplement (the "Second Prospectus Supplement") in connection with Medium Term Notes (the "Notes") issued from time to time under the Issuer's Medium Term Note Program (the "Program"). The Issuer has also prepared a prospectus dated June 26, 2020 (the "Base Prospectus," as amended or updated from time to time and including all information incorporated by reference therein) and a first prospectus supplement dated February 23, 2021(the "First Prospectus Supplement and, together with the Base Prospectus the "Prospectus") for use in connection with the issue of Notes under the Program. This Second Prospectus Supplement amends and updates the Prospectus, and should be read in conjunction with the Prospectus and constitutes a supplement for the purposes of Article 23 of the Prospectus Regulation.

The Second Prospectus Supplement has been approved by the Central Bank of Ireland (the "Central Bank") as competent authority under the Prospectus Regulation. The Central Bank only approves this Second Prospectus Supplement as meeting the standards of completeness, comprehensibility and consistency imposed by the Prospectus Regulation.

The Annual Report has been previously published or is published simultaneously with this Second Prospectus Supplement and has been filed with the Central Bank, and shall be deemed to be incorporated by reference in, and to form part of, this Second Prospectus Supplement. The Annual Report will be available for collection and inspection as set out in the section "Documents on Display" on page 139 of the Base Prospectus and is available at the following link: https://santandercl.gcs-web.com/static-files/25afd67a-8bde-4cf8-b676-e1406bde5ba6.
